- ◆ **Payments are due ten days prior to the start of each month of service.**
- ◆ Students not registered and paid in full ten days prior to the start of each month will be excluded from the program until all obligations have been fulfilled.

Extended Day Enrichment Program

The purpose of this program is to provide tutoring and homework assistance in all subject areas. Students will engage in arts and crafts, games, outdoor activities, computer time, and more.



An afternoon snack will be provided.

Students who have a special diet or food allergy may bring in a snack.

The program begins Wednesday September 6, 2017. The morning session is from 7:00-8:45am. The afternoon session is from 3:45-6:00pm.

NOTE: There is NO extended day program on holidays or emergency school closings. On early dismissal days, there is NO afternoon session. For delayed openings, there is NO morning session.

Upon arrival, children must be walked into the multi-purpose room and signed in by a parent or guardian. Children must be picked up by 6:00pm. Please provide proper identification when picking up your child; no child will be dismissed to an adult not on the emergency contact form or who fails to produce proper identification.

A \$10 late fee per child will occur if your child is not picked up by 6:00pm. NO EXCEPTIONS!

Abuse of this policy will result in the child's dismissal from the program.

We will no longer be accepting payment on a weekly basis; the minimum fee per month will be \$20.

Payments may be in the form of cash, check (non-sufficient fund fees will be applied directly to your account), or money order. Paypal is also available on the school's website, which will enable you to pay online via credit or debit card. Discounts are given at a 25% reduction for each additional child enrolled. The program will be free to those families that qualify through Quality Care.
